<b>Example:</b>	<p>If your birth, incorporation or partnership month is in July and you are applying in August, your prorated certification fee is <b>\$527.08</b>. The application fee must be paid by check, money order or cashier's check made out to the <i>Board of County Commissioners</i>. The fee can also be paid by a Visa or MasterCard credit card if applying in person. Applications can be submitted between the hours of 8:00am and 3:30 PM, Monday through Friday, except holidays.</p>
