



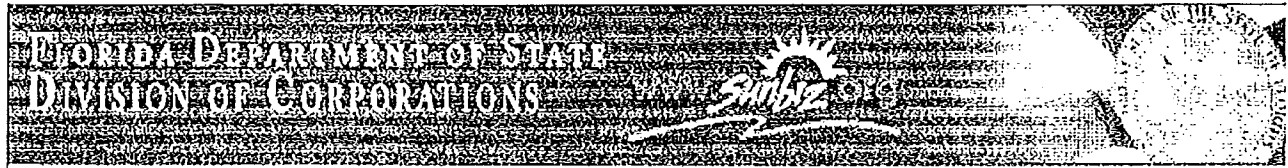

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services has been requested by a not-for-profit organization, Perrine Baseball and Softball Association, Inc., for their "July 4th Celebration" event scheduled for July 4, 2010.

In-kind services have been requested in an amount not to exceed \$10,000 from the Miami-Dade Police Department for personnel services. This event will be funded from the unspent balance of the District 8 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Perrine Baseball and Softball Association, Inc., received no funding for this event.
